Terms and Conditions of Registration - AOPA Luxembourg Safety Seminar

Updated October 17, 2025

Please read these terms and conditions carefully.

Purpose and Scope

These Terms and Conditions (hereinafter the "Terms") govern registration and participation in the Safety Seminar (hereinafter the "Event") organized by AOPA Luxembourg, a non-profit association (association sans but lucratif – a.s.b.l.) governed by the laws of the Grand Duchy of Luxembourg (the "Organizer").

By submitting the online registration form, the attendee (the "Attendee") agrees to be bound by these Terms.

Registration and Payment

Registration for the Event is completed via the Organizer's designated online registration platform. Registration is considered final upon receipt of the completed registration form. By completing registration, the Attendee acknowledges and agrees to pay the attendance fee in full, even in cases of non-attendance, cancellation, or withdrawal for any reason, except as stated below.

Cancellations must be submitted in writing to the Event email address (safetyseminar@aopa.lu) and received prior to the event registration deadline published on the Event website. Cancellations after this deadline, or non-attendance without written notice by the deadline, shall not entitle the Attendee to any refund or credit.

Right of Withdrawal

Pursuant to Article L.221-3 of Luxembourg's Code of Consumption and EU law, the Attendee acknowledges that registration for an event occurring on a specified date is exempt from the statutory 14-day right of withdrawal; thus, after registration deadline passes, no refunds will be issued.

Event Schedule and Modifications

The Organizer reserves the right to modify, postpone, or cancel any part of the Event, including but not limited to schedule, program, speakers, or location, at any time and without prior notice. Such modifications do not entitle the Attendee to refunds, compensation, or damages.

Personal Data Processing

By registering, the Attendee consents to the Organizer's collection, storage, and processing of personal data (name, contact details, and dietary preferences, if applicable) solely for managing participation and administrative purposes, in accordance with Regulation (EU) 2016/679 (GDPR) and Luxembourg law. Data will be retained only as long as necessary to fulfill event administration and legal obligations.

Attendee may access, rectify, or request deletion of their data by sending an email to <u>safetyseminar@aopa.ly</u> and specifically requesting this deletion. The Organizer will not share personal data with third parties except as required for event execution (e.g., catering).

Photography and Communication

The Organizer may take photographs or videos for event promotion and related communication. Attendee grant permission for such use unless they object in writing prior to the Event. Any objection to image use can be submitted at any time before the Event to safetyseminar@aopa.lu.

Liability

The Organizer is not liable for loss, damage, injury, or inconvenience from attendance or non-attendance, except in cases of gross negligence or willful misconduct. Travel, accommodation, and insurance are the responsibility of the Attendee.

Governing Law and Jurisdiction

These Terms are governed by Luxembourg law. Any dispute arising out of or in connection with the Event or these Terms falls under the exclusive jurisdiction of the courts of Luxembourg City.

General Provisions

The invalidity of any provision does not affect the remainder. The Organizer may amend these Terms at any time with updated versions published on the registration platform and/or Event website.
